#### **Rules for Entry**

**Scientific Poster Presentation:** A visual presentation of the scientific paper on Mental Health Nursing specialties by an individual for display

Size of poster/flex should be approximately 30×40 inches.

- 1. Ideas depicted in the poster should be relevant to the study.
- 2. Lettering and design of the poster should be bold and big enough to be seen from a distance.
- 3. The layout of the picture, if any, must be properly balanced to give a correct sense of proportion.
- 4. Extra fixing of clippings/cuttings or any other form on the poster should be avoided.
- 5. The poster should depict the following: Introduction, Need and Significance, Problem Statement, Objectives, Review of Literature (two relevant studies), Brief description of methods and Procedure, Findings and interpretation to be placed in one or two tables, Discussion of your findings to be linked with findings of your previous study, Conclusion, Implications, Recommendation and References/Bibliography
- 6. Poster should not have any identification of the presenter (code will be given before display)
- 7. The Date and time of displaying the poster will be communicated through mail
- 8. All exhibitors should do the registration for the congress.

- The Studies carried out within three years period only shall be entertained
- The researcher/presenters should be a member of TNAI. The word limit for the scientific poster presentation is 2000. Enclose separate sheet for author/authors name, brief bio data, complete address, phone number, email.
- No TA/DA will be provided to the Poster Presenters.
- Abstract to be sent on or before October 10<sup>th</sup> 2017, to the TNAI Headquarters, L-17, Florence Nightingale Lane, Green Park, New Delhi-110016 for scrutiny and selection at the national level.

The scientific paper should contain: Introduction, Need and Significance, Problem Need and Significance, Problem Statement, Objectives, Review of Literature (two relevant studies), Brief description of methods and Procedure, Findings and interpretation to be placed in one or two tables, Discussion of your findings to be linked with findings of previous study, Conclusion, Implications, Recommendation and References/Bibliography
- 3. The study carried out within three years period are only entertained.
- 4. One member can present one paper only
- 5. Maximum Two authors can present one paper
- 6. All presenters should do the registration for the congress.

- The researcher/presenters should be a member of TNAI. The word limit for the scientific paper presentation is 2000. Enclose separate sheet for author/authors name, brief bio data, complete address, phone number, email.
