

Wednesday 23 September 2026



The CNMF is pleased to announce that the 27th CNMF Biennial Meeting of Members will be held on Wednesday 23 September 2026 in New Delhi India.

NEW MATERNAL AND NEWBORN CARE TOOLKITS FROM THE WHO

The World Health Assembly has produced two new toolkits addressing maternal and newborn care.

The first toolkit is titled: *Toolkit for adaptation of the WHO recommendations for a positive pregnancy and postnatal experience*. The second is titled: *Toolkit for implementation of the WHO intrapartum care and immediate postnatal care recommendations in health-care facilities*.



In 2016, the WHO released recommendations on the routine antenatal care for all women and adolescent girls and in 2022, recommendations were released on maternal and newborn care for a positive postnatal experience.

The WHO acknowledge that introducing the WHO ANC and PNC models in different countries requires adapting them to existing health systems which may require extensive reform of existing health programs.

The toolkits were developed with the aim of helping national governments to adapt the 2016 and 2022 WHO recommendations to their context.

The primary target audience for the toolkits are policy-makers, program managers, program implementers, and other decision-makers involved in the planning and management of maternal and child health services in their countries. CNMF encourages all nurses and midwives to download and read the toolkits and work toward implementing the WHO recommendations in their countries.
